## The launch of e-learning – The implementation of BYOD policy

For encouraging schools to promote the use of mobile devices and facilitating e-learning, EDB has launched The Fourth Strategy on IT in Education. The launch of BYOD has become more common among schools. Our school has introduced e-learning across different levels and students are allowed to bring their own devices to school, hence the mobilized and personalized learning has been greatly advocated. Owing to the fact that the development of BYOD may put pressure on the lower income groups, the Quality Education Fund has reserved a grant for implementing a three-year programme since the academic year of 2021/22, in which schools lend mobile devices and the accessories to the eligible students for fostering the development of e-learning.

Under the newly launched BYOD programme, each eligible student can only apply once and the device is owned by the school. If the student has received the assistance provided by Community Care Fund on purchasing a mobile device and the device has been used for three years or the device is out of order or does not support the school settings, the student can borrow another device from our school.

Students under Comprehensive Social Security Assistance or with full grant or half grant and students from less advantaged families are eligible and the assistance includes:

- 1. a mobile device;
- 2. Mobile Device Management (MDM);
- 3. Accessories including a screen protector and a case;
- 4. 3-year maintenance service


