Dear Parents and guardians,

Parent Consultation: Proposed Adjustment of the Charges for Approved Charges for Non-standard Items (ACNI) (2026/2027)

The school is now seeking parents' views on the proposal to adjust the school's charges for Approved Charges for Non-standard Items (ACNI).

After careful analysis and deliberation by the Incorporated Management Committee (IMC) and the Finance Committee, it is proposed that the ACNI be adjusted to **\$470 per year**, which falls within the fee range approved by the Education Bureau. The current ACNI includes the Student Union membership fee (\$20), House fee (\$30), Parent-Teacher Association membership fee (\$20 per household), Student Card fee (\$10), and the School Development Fund (\$150). This proposed adjustment mainly involves increasing the School Development Fund to **\$390**, in order to meet various necessary expenditures, including the enhancement of security systems and campus facilities, as well as the repair or replacement of non-subsidised school equipment.

The school will review the relevant charges every three years to ensure that, while fulfilling its financial responsibilities, it can continue to provide students with a safe and high-quality learning environment. Since 2014, the School Development Fund has remained at \$150 without any adjustment. In the past, accumulated funds have enabled the school to install access control systems, smart boards, and other facilities. However, with rising costs and a 10% reduction in the Expanded Operating Expenses Block Grant (EOEBG) by the government, the school can no longer rely on accumulated income to offset deficits, which would otherwise affect the quality of education.

We sincerely hope for parents' support of this proposal. Your understanding and cooperation will help the school maintain a high standard of education and respond to students' diverse learning needs amid ongoing educational changes.


