1. Submission of Supporting Documents for Eligibility of Education Bureau Activity Subsidies or Grants

If the relevant documents are not submitted, the school will assume that the family is not receiving Comprehensive Social Security Assistance from the Social Welfare Department.

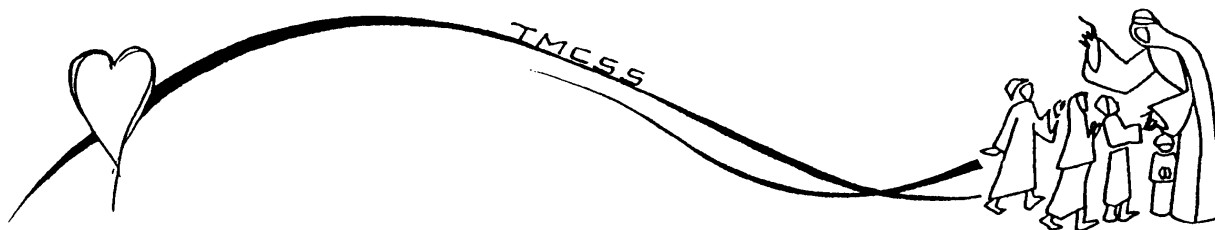


Option B: Paper Enrolment
