1. Qualifications

All current Primary Six students from any districts are eligible for application.

2. Application Procedure

2.1 Collecting Application Form

No printed forms are available and applicants should complete the application form online from 2nd January to 16th January. All applicants are required to fill in the form available in https://web.tmcss.edu.hk/self admission/.



2.2 Submission of Application

(For the submission of relevant documents only)

Method: Applicants should submit their application in person or through SSPA e-

platform. Whatever the above application methods, applicants are required to complete the online application form provided by our school as mentioned above. If necessary documents are not provided, the application is not

acceptable.

Method 1: Applicants submit the Application Form for Secondary One

Discretionary Place and the relevant documents in person;

Method 2: Submit the relevant documents as instructed on SSPA e-platform.

2.3 Application Fee

HK\$30 will be collected upon receiving the application form from the applicant.

2.4 Hong Kong Education Bureau's restriction on the application

Each student may apply to no more than two participating secondary schools for Discretionary Places or else the chance of acquiring a DP will be forfeited.

Whatever the submission through a printed application form or SSPA e-platform, once the application is submitted, the application is not going to be withdrawn and cancelled. The priority of your preferences is not going to be adjusted.

3. Number of Students to be admitted

40 students will be admitted.

4. Interview

- 4.1 All applicants of Form One Discretionary Places will be invited for an interview. Applicants with good performance will be shortlisted for the second interview.
- 4.2 Announcement date:

First interview: 22nd January, 2024 Second interview: 4th March, 2024

- 4.3 List of interviewees will be posted at the school lobby and on school website (http://www.tmcss.edu.hk).
- 4.4 Date of interview:

First interview: 3rd February, 2024 (Saturday) Second interview: 17th March, 2024 (Sunday)

- 4.5 Applicants should bring along original certificates and document for verification when attending the first interview.
- 4.6 Parents are advised to accompany their children in the second interview.
- 4.7 Online interviews are not available. Make-up interviews will also not be available for absentees. Applicants should reserve enough time for attending the interviews.

5. Admission Criteria

Our school puts great emphasis on the whole person development. All applicants are expected to attain good conduct grades.

5.1 Academic results: 40%
5.2 Performance in the interview: 50%
5.3 Extra-curricular Activities: 10%
